WHO WE ARE

Resonance is a social enterprise and FCA authorised investment fund manager that has been "connecting capital to social enterprise" across the UK for over 20 years. We have worked with nearly 150 social enterprises and charities, enabling them to raise capital to grow their impact and make a difference to the communities they serve.

Resonance's overarching purpose is making investment a force for good and transforming lives through investment. Resonance is half owned by charitable foundations and impact investors and half owned by Resonance directors and employees. Our Vision, Mission and Values are on page six.

WHAT WE DO

As an FCA authorised fund manager Resonance looks after around £440m of other people's money, investing to enable social enterprises to provide homes and scale solutions for people facing crisis in the heart of communities across the UK. To date our funds have acquired over 1300 homes and backed over 120 social enterprises.

Resonance' has won a number of national awards including the Natwest SE100 "Deal of the Decade" and the Housing Heroes "team of the year".

OVERALL PURPOSE OF THE ROLE

As well as bringing boundless energy to the role, you'll have the ambition to want to learn how our business works, understand our passion and our purpose, support and enable other leaders in the business to reach their goals, and use your drive to ensure that timescales are met.

You'll be working across the organisation, but with particular focus on our Impact Labs work, investing in social enterprises and strengthening their impact, reporting to the Chief Investment Officer, and with an additional reporting line to the Chief Executive Officer. This key role is important to our future success.

You'll be based in one of our offices, either Launceston, Manchester, Bristol or London (a modest London weighting of £5,154 may be available). Whilst we operate a highly flexible, hybrid working style, with a 9-day working fortnight, we also highly value the time spent together with colleagues and encourage at least 2 days per week in the office.

HERE'S WHAT YOU'LL DO WITH US - RESPONSIBILITIES

You will provide overall leadership for Resonance's Impact Labs business, through which we deliver direct investment and support to social enterprises across the UK through the following established, successful and growing initiatives:

Growing Enterprises – through which we invest our funds in growing social enterprises with a huge range of social impacts and business models

Developing Communities – through which we invest our funds in helping community-led enterprises develop assets their neighbourhoods need to flourish, including local affordable housing, sports and leisure, and renewable energy projects

Strengthening Impact – through which we provide both internal and external consultancy services to help social enterprises strengthen their business and impact

Funding Partnerships – through which we channel other funding sources, either grant or investment, into social enterprises connected with our other activities

Our Impact Labs business is a key aspect of Resonance's overall strategy in delivering its mission to "connect capital to social enterprise". It is symbiotic with our other main activity delivered through our Property Funds, recognising that people need more than just a roof over their head. Through our Impact Labs work we are helping a wide range of social enterprise solutions for people facing crisis which complement good housing solutions.

You will lead a team of around 17 people which has Operating Heads roles for each of the four areas above comprising an existing "Impact Labs Leadership Team" (ILLT), and team members in each team with significant skills and experience in these areas. As such, your leadership role will be to support, empower and coordinate their work, as well as making significant contributions to key areas where additional experience and capacity will aid the overall team's progress, particularly by helping raise Resonance's profile with external investors and grant funders and bringing new investment and grant into the existing fund initiatives.

Key areas which the role will cover include:

- Helping bring together and shape strategic planning for Impact Labs as a whole, drawing on the experience and ideas of the whole ILLT
- Playing an influential role in bringing in additional grant and investment into Impact Labs funds (currently Resonance Community Developers and Resonance Enterprise Investment funds), in support of the existing teams on these funds
- Creating further inter-connectivity and symbiosis between Impact Labs and Property Funds, particularly linked to place-based strategies in the regions where these activities overlap
- Helping build strong operational processes for Resonance's Impact Labs funds as they scale, drawing on relevant support across relevant areas including risk management, compliance, legal and IT
- Overseeing planning and delivery of financial forecasts for Impact Labs, in conjunction with ILLT and the Finance Team
- Supporting Operating Heads and line managers to fully develop the potential of a highly skilled and motivated team, and to grow that team in line with scaling of activity, in conjunction with the People Team

There is potential for the Head of Impact Labs role to also play a part in the overall Resonance Leadership Team, given it will be helping to provide overall leadership to a significant part of our operations.
