Resonance launched in 2002 with the mission of connecting capital to social enterprise, we are proud of our twenty-three year track record of impact investing, and our B Corp certification.

We provide life changing homes and solutions for people and communities facing crisis.

We are an FCA approved fund manager, and through our pioneering social impact residential property funds, we work with institutional investors and expert housing partners to provide safe, affordable, and settled homes, with the appropriate support for tenants. Since our first property fund launched in 2013, we have helped to provide homes for over 4,000 individuals, including 1,958 children in 1,300 properties in major cities across the UK.

With peoples' homes at the heart of what we do, our Impact Labs team develops the ecosystem around our impact property funds, so we can innovate new solutions, pilot systemic change, increase supply and scale opportunity.

To date we have raised and invested nearly £500m and we take pride that our funds deliver good returns to investors as well as real and measurable social impact. We have an exciting future planned, our aim is to bring our Funds Under Management to £1bn, which means that we can help even more individuals, families, social enterprises and communities across the UK.

We are particularly looking for people with a strong understanding of and credibility within residential property and digital transformation.

As a NED, you will provide independent oversight, strategic counsel, and governance expertise, ensuring that our activities remain aligned with our social and environmental goals while maintaining robust financial performance.
